There are two types of licenses:

- Cisco Unified MeetingPlace Express uses premium licenses.
- Cisco Unified MeetingPlace Express VT uses standard licenses.

Licenses enable specific features and capabilities on the system. You purchase license SKUs with your Cisco Unified MeetingPlace Express order and install the license file for that order to enable the features and capabilities that you purchased. You may also upgrade your system by purchasing and installing additional licenses.

## Premium and Standard Licenses

- Premium licenses-Used for scheduled and reservationless voice, web, and video meetings. Used with the Cisco Unified MeetingPlace Express system; cannot be used with the Cisco Unified MeetingPlace Express VT system.

When the [systemsoftware](#) license is installed, the system is enabled with the premium (scheduled) voice, web, and video license counts and six trial standard (ad hoc) voice and video licenses. If you install the [systemsoftware](#) license, the web ports in your system can be used for either premium (scheduled) meetings or standard (ad hoc) meetings.

- Standard licenses-Used for ad hoc voice, web, and video meetings. Used with the Cisco Unified MeetingPlace Express VT system; cannot be used with the Cisco Unified MeetingPlace Express system.

When the [stdsw](#) license is installed, the system is enabled with the standard (ad hoc) voice, web, and video license counts and six trial premium (scheduled) voice, web, and video licenses. Standard (ad hoc) meetings and web support are provided only through Cisco Unified Personal Communicator.

If you do not install any licenses on your system, by default you have six trial premium (scheduled) licenses for each of voice, web, and video and six trial standard (ad hoc) licenses for each of voice, web, and video. On all systems, the web ports are shared between premium (scheduled) and standard (ad hoc).

## License Restrictions

- If you upgrade to Release 2.x from an earlier release of Cisco Unified MeetingPlace Express, you must install the relevant upgrade licenses. Many licenses from earlier releases of Cisco Unified MeetingPlace Express do not work with Release 2.x.
- Although you can install both the standard ([stdsw](#)) and premium ([systemsoftware](#)) licenses on the same system, they cannot both be active on the same system. If you install both licenses on your system, the premium ([systemsoftware](#)) license takes precedence.

For example, suppose that you install the [stdsw](#) license on your system. If you then want to install a new license file that includes the [systemsoftware](#) license, you must select the [Upload new license file](#) installation option, which deletes all previously installed licenses before installing the new license file. See the [Installing the License File](#) for more information.

This restriction means that you can use your system for either standard (ad hoc) conferencing or for premium (scheduled) conferencing.

**Note:** Your system comes with six trial licenses that you may use to experiment with unlicensed features.

- By default, every Cisco Unified MeetingPlace Express system comes with six trial voice licenses, six trial web licenses, and six trial video licenses for standard (ad hoc) conferencing. If you do not purchase additional licenses, the six trial web licenses expire after 60 days. The system also comes with six trial standard (ad hoc) licenses.
- The premium ([systemsoftware](#)) license upgrades a system running in standard (ad hoc) mode, to a system running in premium (scheduled) mode. When such an upgrade occurs, the standard (ad hoc) portion of the system is limited to the six trial voice licenses, six trial web licenses, and six trial video licenses and cannot be expanded. The web licenses (which may be more than six if you have purchased additional ones), can be used for either scheduled and reservationless (premium) or ad hoc (standard) meetings.
- Depending on how your system is configured, you may not be able to take advantage of all the licenses you purchase. That is, the Cisco Unified MeetingPlace Express system lets you purchase more licenses than your current system capacity. For more information about system capacity, see the [System Capacity Planning](#).

## License Expiration

- All licenses used for customer demonstration purposes expire.
- The system does not consider the expiration date of a license when users *schedule* meetings; instead, the system checks and enforces the expiration date when users *join* meetings. The system displays a message if a license is about to expire.
- If a license has an expiration date, it is displayed in the Comment field on the Licenses Summary page.
- The system displays a warning message on the Administration Center home page two weeks before a license will expire.

License	Description
exchange	<p>The <a href="#">exchange</a> license enables you to integrate your Cisco Unified MeetingPlace Express system with a Microsoft Exchange Server. This allows your users to schedule and manage meetings from the Microsoft Outlook Calendar and send and receive Microsoft Outlook Calendar notifications.</p> <p>The <a href="#">exchange</a> license is a non-counted license, which means it is either set to Yes or No.</p> <p>If you do <i>not</i> install the <a href="#">exchange</a> license, you cannot integrate Cisco Unified MeetingPlace Express with Microsoft Outlook. One exception is that if the <a href="#">systemsoftware</a> license is <i>not</i> installed, Microsoft Outlook functionality is enabled for trial and demonstration purposes.</p>
languages	<p>The <a href="#">languages</a> license enables the simultaneous use of up to four supported languages on a system. If you do <i>not</i> install the <a href="#">languages</a> license, you can enable only one language.</p> <p>The <a href="#">languages</a> license is a non-counted license, which means it is either set to Yes or No.</p> <p><b>Note:</b> The <a href="#">languages</a> license is not required for ad hoc meetings because there are no voice prompts and ad hoc meeting users do not access the End-User Interface.</p>
maxstd	

	<p>The <u>maxstd</u> license denotes the maximum number of standard (ad hoc) voice, web, or video licenses that can be used on this particular system, due to system restraints. If the <u>stdvoiceconf</u>, <u>webconf</u>, or <u>stdvideoconf</u> license count exceeds the value of the <u>maxstd</u> license, the system uses the value of the <u>maxstd</u> license instead.</p>
maxvideo	<p>The <u>maxvideo</u> license denotes the maximum number of video licenses that can be used for scheduled and reservationless meetings on this particular system. If the <u>videoconf</u> license count exceeds the value of the <u>maxvideo</u> license, the system uses the value of the <u>maxvideo</u> license instead.</p> <p>The value of the <u>maxvideo</u> license is the absolute system limit for video conferencing.</p> <p>Any <u>maxvideo</u> license limitations for your system appear in the <u>Comment</u> field on the Licenses Summary page. To find this page in the Administration Center, see the <u>Displaying Licenses</u>.</p> <p>Restriction: If you purchase and install a new <u>maxvideo</u> license, it overwrites the old one. The new port count is not added to the previous port count.</p>
maxvoice	<p>The <u>maxvoice</u> license denotes the maximum number of voice licenses that can be used for scheduled and reservationless meetings on this particular system. If the <u>voiceconf</u> license count exceeds the value of the <u>maxvoice</u> license, the system uses the value of the <u>maxvoice</u> license instead.</p> <p>The value of the <u>maxvoice</u> license is the absolute system limit for voice conferencing.</p> <p>Any <u>maxvoice</u> license limitations for your system appear in the <u>Comment</u> field on the Licenses Summary page. To find this page in the Administration Center, see the <u>Displaying Licenses</u>.</p> <p>Restriction: If you purchase and install a new <u>maxvoice</u> license, it overwrites the old one. The new port count is not added to the previous port count.</p>
maxweb	<p>The <u>maxweb</u> license limits the number of web ports that can be used for scheduled and reservationless meetings on your system. For example, if the <u>webconf</u> license port count is greater than the <u>maxweb</u> license port count, then the system uses the port count specified in the <u>maxweb</u> license.</p> <p>The value of the <u>maxweb</u> license is the absolute system limit for web conferencing.</p> <p>Any <u>maxweb</u> license limitations for your system appear in the <u>Comment</u> field on the Licenses Summary page. To find this page in the Administration Center, see the <u>Displaying Licenses</u>.</p> <p>Restriction: If you purchase and install a new <u>maxweb</u> license, it overwrites the old one. The new port count is not added to the previous port count.</p>

secondaryservers	<p>The <a href="#">secondaryservers</a> license determines whether a connection can be established to the secondary server. This is used for segmented meeting access (SMA).</p> <p>The <a href="#">secondaryservers</a> license can also be used for larger systems where web conferencing needs to run on the secondary server so that voice and video conferencing can be scaled on the primary server.</p>
stdsw	<p>The <a href="#">stdsw</a> license enables the system to use the <a href="#">stdvoiceconf</a>, <a href="#">webconf</a>, <a href="#">stdvideoconf</a>, and <a href="#">maxstd</a> licenses for standard (ad hoc) conferencing. (If the <a href="#">systemsoftware</a> license, which denotes that the system is operating in the premium mode, is loaded, the <a href="#">stdsw</a> license is ignored.)</p> <p>The <a href="#">stdsw</a> license has a version number and the system determines if this license is valid based on the version number.</p> <p>Restrictions:</p> <ul style="list-style-type: none"> <li>• You cannot install both the <a href="#">systemsoftware</a> and <a href="#">stdsw</a> licenses on the same server.</li> <li>• If you do <i>not</i> install the <a href="#">stdsw</a> license, the system can use only the six trial voice ports, six trial video ports, and six trial web ports for standard (ad hoc) conferencing. The six trial web ports expire 60 days after system installation, unless you install a <a href="#">webconf</a> license to make them permanent.</li> </ul>
stdvideoconf	<p>The <a href="#">stdvideoconf</a> license limits the number of concurrent standard (ad hoc) video conferencing participants. This number may be further limited by the <a href="#">maxstd</a> license. If you do <i>not</i> install the <a href="#">stdvideoconf</a> license, the system can use only the six trial video ports for standard (ad hoc) conferencing.</p> <p>The actual number of usable standard (ad hoc) video ports on the system depends on the configured value of the <a href="#">Video maximum bit rate</a> parameter. See the <a href="#">About Video Ports for Ad Hoc Conferencing</a>.</p> <p>Restrictions:</p> <ul style="list-style-type: none"> <li>• Standard (ad hoc) video licenses that exceed the total number of standard (ad hoc) voice licenses cannot be used.</li> <li>• The maximum value for this license is 40.</li> </ul>
stdvideoupg	<p>The <a href="#">stdvideoupg</a> license allows you to upgrade standard (ad hoc) video licenses to premium (scheduled) video licenses when upgrading Cisco Unified MeetingPlace Express VT to Cisco Unified MeetingPlace Express. The <a href="#">stdvideoupg</a> license essentially changes the <a href="#">stdvideoconf</a> license into a <a href="#">videoconf</a> license.</p>
stdvoiceconf	<p>The <a href="#">stdvoiceconf</a> license limits the number of concurrent standard (ad hoc) voice conferencing participants. This number may be further limited by the <a href="#">maxstd</a> license. If you do <i>not</i> install the <a href="#">stdvoiceconf</a> license, the system can use only the six trial voice ports for standard (ad hoc) conferencing.</p>
stdvoiceupg	<p>The <a href="#">stdvoiceupg</a> license allows you to upgrade standard (ad hoc) voice licenses to premium (scheduled) voice licenses when upgrading Cisco Unified MeetingPlace Express VT to Cisco Unified MeetingPlace Express. The <a href="#">stdvoiceupg</a> license essentially changes the <a href="#">stdvoiceconf</a> license into a <a href="#">voiceconf</a> license.</p>

systemsoftware	<p>The <u>systemsoftware</u> license enables the system to use the <u>voiceconf</u>, <u>webconf</u>, and <u>videoconf</u> licenses for premium (scheduled) meetings. If you do <i>not</i> install the <u>systemsoftware</u> license, the system can use only the six trial voice ports, the six trial web ports, and the six trial video ports for premium (scheduled) meetings.</p> <p>The <u>systemsoftware</u> license has a version number and the system determines if this license is valid based on the version number.</p> <p><b>Note:</b> The six trial web ports expire 60 days after system installation, unless you install a <u>webconf</u> license to make them permanent.</p> <p>Requirements:</p> <ul style="list-style-type: none"> <li>• To obtain a <u>systemsoftware</u> license, purchase a base software SKU or a software version upgrade. You cannot obtain a <u>systemsoftware</u> license by purchasing a capacity or platform upgrade.</li> <li>• The version number specified by the <u>systemsoftware</u> license must be greater than or equal to the first digit of the installed software version number.</li> </ul> <p>Restriction: You cannot install both the <u>systemsoftware</u> and <u>stdsw</u> licenses on the same server.</p>
videoconf	<p>The <u>videoconf</u> license limits the number of concurrent video participants for premium (scheduled) meetings. The available number of video ports may be further limited by the <u>maxvideo</u> license.</p> <p>If you do <i>not</i> install the <u>videoconf</u> license, the system can use only the six trial video ports for premium (scheduled) meetings. (A port is defined as a single video caller connecting at any rate.)</p> <p>Requirement: To enable the system to use the <u>videoconf</u> license for premium (scheduled) meetings, you must install the <u>systemsoftware</u> license.</p>
voiceconf	<p>The <u>voiceconf</u> license limits the number of concurrent voice participants for premium (scheduled) meetings, including:</p> <ul style="list-style-type: none"> <li>• Calls to and from the system</li> <li>• Voice participants in meetings</li> </ul> <p>The available number of voice ports may be further limited by the <u>maxvoice</u> license.</p> <p>If you do <i>not</i> install the <u>voiceconf</u> license, the system can use only the six trial voice ports for premium (scheduled) meetings.</p> <p>Requirement: To enable the system to use the <u>voiceconf</u> license for premium (scheduled) meetings, you must install the <u>systemsoftware</u> license.</p>

webconf	<p>The <u>webconf</u> license is defined as follows:</p> <ul style="list-style-type: none"> <li>• If you install the <u>stdsw</u> license, the <u>webconf</u> license limits the number of available standard (ad hoc) web ports on the system. This number may be further limited by the <u>maxstd</u> license.</li> <li>• If you install the <u>systemsoftware</u> license, the <u>webconf</u> license limits the number of concurrent participants using the full web meeting room for scheduled or reservationless meetings. This number may be further limited by the <u>maxweb</u> license.</li> </ul> <p><b>Note:</b> If you want all or most users to be able to schedule full web meetings, install an equal number of voice ports and web ports through the <u>voiceconf</u> and <u>webconf</u> licenses.</p> <ul style="list-style-type: none"> <li>• If you do <i>not</i> install either the <u>stdsw</u> license or the <u>systemsoftware</u> license, the <u>webconf</u> license makes the six trial web ports permanent.</li> <li>• If you do <i>not</i> install the <u>webconf</u> license, the system can use only the six trial web ports, which expire 60 days after system installation. If you purchase a base software SKU, your order comes with a trial <u>webconf</u> license that makes the six trial web ports permanent after you install the license.</li> </ul>
